### **PRAIRIE WOODLAND CONSERVATION FOUNDATION SCHOLARSHIP**

#### **PROGRAM PURPOSE**

The purpose of the Prairie Woodland Conservation Foundation (PWCF) Scholarship Program is to assist students' learning process by providing financial assistance via scholarships. This scholarship has been renamed the Bennie F. Hall Prairie Woodland Conservation Foundation Scholarship.

#### **PROGRAM SCOPE**

The Scholarship Program scope encompasses college students studying conservation and outdoor recreation related majors and/or graduating high school seniors that have demonstrated their concern for conservation. Qualifying applicants are divided into two distinct groups:

**Graduating High School Seniors who plan conservation related fields as a major in college.** Only students that are residents of Guthrie County are eligible and may apply in their senior year.

**College Students with Conservation Related Majors that have completed at least their sophomore year in college.** Only college students with permanent residency in Guthrie County are eligible and may apply while in or after their second semester of sophomore year.

#### **FINANCIAL SCOPE**

The financial assistance available will be determined by the PWCF board based on qualified applications and shall be funded through the Foundation's annual budget and subject to approval by the board, but will typically be at least \$500.

#### **PROGRAM TIMETABLE**

College scholarship applications will be accepted until **April 16, 2018** by the Prairie Woodland Conservation Foundation. Publication will be through the local newspapers and local high schools will be contacted. The scholarship applications will be reviewed by the PWCF and awarded at the Spring Board meeting. College freshmen will receive the scholarship funds at the beginning of their second semester after their first semester grades have been reviewed. College junior recipients will have their sophomore grades reviewed and will receive their scholarship funds prior to the beginning of their junior year.

#### **APPLICATION PROCEDURES**

1. Students must complete an application form. (These forms may be duplicated as needed.)
2. Return the application to the mailing address below as soon as possible.
3. PWCF will review the applications and determine the winner(s).
4. PWCF will contact the recipient to review grades after the end of the first semester. Criteria will be GPA of at least 3.0 on 4.0 grading scale with a minimum of 12 credit hours or full time student status.
